

Notice of Joint Public Hearing

The Proposed Merger of School for Excellence (09X404) with Morris Academy for Collaborative Studies (09X297) in Building X400 in the 2024-2025 School Year

A Joint Public Hearing will be held to provide the public with an opportunity to learn more about the above-referenced proposal and to present comments or concerns on the proposal. The date, time, and location of the hearing are as follows:

This Joint Public Hearing will be an opportunity to learn more about potential changes to building X400 and share feedback.

The New York City Department of Education (NYCDOE) is proposing to merge School for Excellence (09X404), referred to as SFE, with Morris Academy for Collaborative Studies (09X297), referred to as MACS, in building X400 (X400) in the 2024-2025 school year.

A merger means that two or more existing school organizations are combined into one school to operate and serve students more effectively. Proposals for mergers seek to improve learning environments by combining the strengths and best practices of both schools and distributing resources to reinforce academic enrichment opportunities, interventions, and other supports.

MACS and SFE are both existing district high schools serving students in grades 9-12 in X400, located at 1110 Boston Road, Bronx, NY 10456 in Community School District 9, referred to as District 9. MACS and SFE are co-located in X400 along with Bronx International High School (09X403), referred to as Bronx International, and High School for Violin and Dance (09X543), referred to as HSVD, which are both also district high schools serving students in grades 9-12. X400 also houses the community-based organizations Center for Supportive Schools, College Confidential, PowerPlay, The Urban Assembly, and Westhab.

If this proposal is approved, SFE will be combined with MACS, such that the students, staff, and resources of SFE will become a part of the merged school, MACS, as of the 2024-2025 school year. If this proposal is approved, SFE will no longer exist as a distinct school option after the 2023-2024 school year.
